This year we earned \$502.38 in income from annual dues which is about 50% of what we normally bring in yearly. Prior to the pandemic, in 2020 Masterpiece International sponsored a travel stipend of \$750.00 of which \$100 was used for this year's virtual conference. Due to the conference being virtual and most institutions limiting in-person gatherings there were no conference expenses or state event support paid out. We had minimal administrative expenses of \$66.00 going towards the annual fee for our website. Museums Evolving 2.0—AMM/WFM Virtual Conference

First and foremost, I would like to extend a heartfelt thank you to the board members of the Midwest Registrars Committee for making scholarships to attend the 2021 AMM-WFM Virtual Conference available. Looking back over the last two years, there is a bit of sadness that comes up when I think about the time that has passed and the comradery that we normally all share at an in-person conference event. But, thanks to the hard work of the Association of Midwest Museums and the Wisconsin Federation of Museums, this year's virtual conference brought museum people together once again, and right from the comfort of our own desk chairs!

The theme of the 2021 conference was "Museums Evolving 2.0" and, in my opinion, 2.0 sums everything up quite perfectly. Just when we thought we were done "evolving" under current circumstances, 2020 rolled into 2021 and it was immediately apparent that museums were going to be faced with a "2.0" of sorts. More uncertainty was on the horizon, and all the skills we gained over the past year in adaptability, flexibility, and patience were to continue to be tested. This year we've strived to learn more how to keep ourselves and our visitors safe in a pandemic, we've adapted our work and programs to virtual formats, and we continue to have much needed, though sometimes uncomfortable and difficult, conversations around inclusion, diversity, equity, and accessibility not only on a personal level in the museum field, but within our collections and exhibits as well. If 2021 were to have an overarching theme, "2.0" hits the nail on the head.

This year's conference offered seven different sessions related to collections stewardship and management that focused on continuing to be creative, adaptable, and inclusive. Keeping with the times, there were interesting sessions on environmental monitoring as it relates to building access during the pandemic, how changes in NAGPRA continue to make outreach and repatriation possible for museums, and the way digital collections are on the rise and how caring for these "new fangled artifacts" is becoming increasingly important.

Austin Senseman from Conserv walked session participants through the positives of having a museum monitoring system that could be accessed remotely, especially in times when our "normal" routine becomes difficult to maintain. There are several companies available to the museum and fine art community that now offer remote monitoring for temperature, relative humidity, light, and more, all via a remote computer log in or virtual application depending on the program. And, luckily for many of us, these remote programs and devices are becoming more common on the market, which means more accessible costs. We can also keep in mind that there may be grants and improvement awards available for updates such as these, which provide clear and easy data that support better collections care and investment.

Friends from the University of Denver Museum of Anthropology, Indiana University Bloomington, and University of Illinois at Urbana-Champaign shared how museums can follow best practices when it comes to

obligations to Tribal Nations and following NAGPRA, the Native American Graves Protection & Repatriation Act. Since it was passed into law in 1990, NAGPRA outlines that any institution receiving Federal funds that hold Native American cultural items including human remains, sacred objects, objects of cultural patrimony, and funerary objects must treat any and all objects with dignity and respect. It also outlines that any cultural items removed from Federal or tribal lands belong to lineal descendants and/or the Native Tribe, and that these objects are required to be repatriated or transferred to the appropriate parties. NAGPRA encourages dialogue between museums and Native tribes in order to evaluate repatriation or disposition requests for cultural items. The presentation outlined "RESPECT" as an easy acronym to remember the purpose and importance when working on NAGPRA compliance: Reciprocity (information sharing), Establish relationships (working), Start before research begins (inclusive consultation), Patience (timelines), Each Indigenous community is unique (do your homework), Check your ego (social norms), and Transparency (remember full disclosure at all times). This presentation was also helpful in reminding everyone that even if your museum is not required to comply with the law (i.e. does not receive Federal funding or grants of any kind), NAGPRA can still be used as an effective roadmap for best practices and repatriation.

Another hot topic in the continued evolution of museums is technology and ever-looming digital collection projects. A panel from three different institutions shared their experiences with spearheading successful and meaningful digital collection projects. They touched on collections containing a variety of content and staffing with a range of knowledge and infrastructure, which was extremely beneficial to me as someone who would fall in the "medium" range of "how comfortable are you with digital collections." At the Kalamazoo Valley Museum, we have spent much of the last two years developing not only continued digitization plans, but also our born digital collections policy, storage solutions, and procedures going forward. It was comforting to hear that many other institutions were in a similar place that we are, and that even the largest institutions were hitting everything from funding snafus to digital storage speed bumps along the way. Some of the best takeaways from this presentation were resources for grant-related initiatives and workflow insight. When it comes to workflow, especially in a time when the demand for digital learning has grown more rapidly than ever, it was helpful to hear reassurance about prioritizing projects that have an immediate need for the children, researchers, and families that use and, in a time when physical access is limited, miss our collections the most.

Finally, I would also like to share a special shoutout to Leslie Ory Lewellen from the Minneapolis Institute of Art, Linda Endersby from the Museum of Art and Archaeology University of Missouri, and Christy Kincaid from the Air Zoo Aerospace and Science Museum of Michigan for joining me in hosting the ever-popular "Ask the Registrar" open forum. Joined by those in attendance, we discussed several conundrums that come with ever-evolving collections, museum technology, staffing issues, and all the red tape we loooove (heavy on the sarcasm there) that comes with being responsible for objects in the public trust. Everyone had excellent input and advice that we hope all in attendance were able to take away to their own museums to continue the good fight for the objects in our care!

News From the Midwest

The Children's Museum of Indianapolis, Indianapolis

The Children's Museum of Indianapolis has been awarded a National Park Service NAGPRA Consultation and Documentation grant to work with consultant experts on different cultural regions of the country, with tribal government representatives on their own cultural artifacts, and with experts in the legal nuances of NAGPRA, to do a new survey of our Native American collections. TCM complied with NAGPRA in the 1990s, but both the law, and the understanding of certain cultural objects has changed since then, as has our institutional understanding of partnering with and honoring native voices. A new survey of the objects in our collection will allow us to improve our record descriptions and cultural affiliations, consult with experts on how certain objects should be respectfully housed in storage, and as necessary, begin a mutual and legal dialogue with appropriate tribes about any objects that under the law should be returned.

Gund Gallery at Kenyon College, Gambier

While the Gund Gallery remains open to the public as well as to those in our campus community, we have shifted our attention to finding ways to connect our work to whomever might want to be our audience, no matter where in the world they might be.

Our Spring 2021 exhibition, *The Art of Trees* (http://

www.thegundgallery.org/2020/12/comingsoon-the-art-of-trees/), was curated by a committee of Gund Associates, Kenyon faculty, and Gund Gallery staff who worked together in a collaborative, multi-year process to bring this project to life. Exploring themes of restoration and destruction, community and isolation, location and identity, and fragile temporalities, the artists featured in the exhibition experiment with a range of mediums, and even use trees as creative collaborators to express our essential and inseparable bond with these guardians of the earth. We've launched a new docuseries, Can't Look Away: Photographs of the Civil Rights Struggle (http://www.thegundgallery.org/2021/02/cant-look-away-photographs-of-the-civil-rights-struggle/), that seeks to reveal connections between the Black Lives Matter movements and the Civil Rights struggles of the 1950s and 60s

through conversations centered on select photographs depicting the Civil Rights Era.

Developed as a way for the Gallery to inspire our community to critically engage with some of the most pressing issues we face today, each episode features experts from across Kenyon College discussing photographs made available for the program by Gund Gallery supporters David Horvitz '74 and Francie Bishop Good. These images demand our attention and compel us to think deeply about the legacy of racism in the United States, leading us to explore how history can inform the ways we respond collectively to the legacy of unresolved racial strife that continues in our time.

And finally, we're proud to announce that our **Near & Far Activation Guides** have won a Gold award from the Ohio Museums Association (OMA) in the 2020 Visual Communication Competition. The entry also won "Best in Show" for this year's program. Like many of our peer institutions, in the last year the Gund Gallery has had to face the challenges of operating in a pandemic. Although we have been open since last August, Near & Far is an umbrella concept that enables us to share our exhibitions and activities with those who can't visit the Gallery in person, whether because of distance or Covid concerns and restrictions. A <u>Near & Far section was added to our website</u>, and for each exhibition, <u>activation guides</u> are developed, printed, and mailed to Gallery friends, stakeholders, and students studying remotely around the world. Each guide introduces the reader to our exhibitions and then asks them to engage with it in a creative way. These prompts can be completed by anyone, anywhere. And each gives you the option of sharing your work with others.

Chazen Museum of Art, Madison

Covid

The Chazen opened to the public on July 14, 2020 with reduced hours, fewer open galleries, and reduced capacity. During the ongoing pandemic, our guidelines for "How to Chazen" have changed to make sure everyone stays healthy. Currently, the first, second and third floors of the Chazen building are open and the Elvehjem building remains closed to the public. We are limiting the number of visitors at any given time to 25 to ensure safety of both staff and visitors, and like the rest of campus, we require masks for entry. We also ask that visitors sign up for an appointment in advance for a (free) visit Tues–Wed 12-5pm; Thurs-Fri, 12–7 p.m.

In response to the ongoing pandemic, the museum also ramped up its virtual offerings to include "Our Kind of Happy Hour," weekly evening Facebook Live events featuring artists and other guests; "Family Fridays," videos demonstrating fun do-at-home projects; Virtual Docent Tours; Virtual Study Room presentations; and Faculty Curricula offerings via Canvas classroom.

New Website

The Chazen Museum of Art unveiled its newly designed website in fall of 2020. The online collection was also redesigned and features new filter and sort features and includes increased content such as provenance and didactic information. The new website was designed by the University of Wisconsin-Madison Marketing Team with collaboration from the museum's Editor, Kirstin Pires, and the Collections Registrar, Andrea Selbig. The Chazen's entire permanent collection of over 23,000 objects is published. Please take a visit at www.chazen.wisc.edu.

Contemporary African Art Initiative

The Contemporary African Art Initiative (CAAI) is a new multi-year project that seeks to expand the Chazen Museum of Art's holdings of contemporary African art. The CAAI is funded by a five-year gift from the Straus Family Foundation.

The CAAI seeks to support contemporary African artists and develop collaborative relationships with organizations in Africa, ensuring that the artwork selected is available for viewing, study and enjoyment by a wide swath of the public at the University, in the community and globally. "Diversifying our permanent collections and better representing the complex and intersectional world in which we live is one of the most pressing issues facing our museum," said Gilman. "This initiative is one way we can impact the collection immediately, and set the stage for long term acquisitions, partnerships and collaborations that can only be imagined today."

Highlights include *Exodus* by Cameroonian artist Barthélémy Toguo, photography by François-Xavier Gbré, Léonard Pongo (Democratic Republic of the Congo), and Lebohang Kganye (South Africa), sculpture by Moataz Nasr (Egypt) and Péju Alatise (Nigeria), and multimedia work by Collin Sekajugo (Uganda, Rwanda).
